










#### Source-Drain Diode Forward Voltage




#### **Threshold Voltage**

Single Pulse Power










T<sub>C</sub> - Case Temperature (°C)

T<sub>A</sub> - Ambient Temperature (°C)









Normalized Thermal Transient Impedance, Junction-to-Foot


