


**Gate Charge** 

**On-Resistance vs. Junction Temperature** 





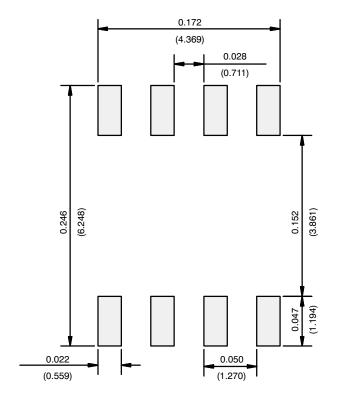
