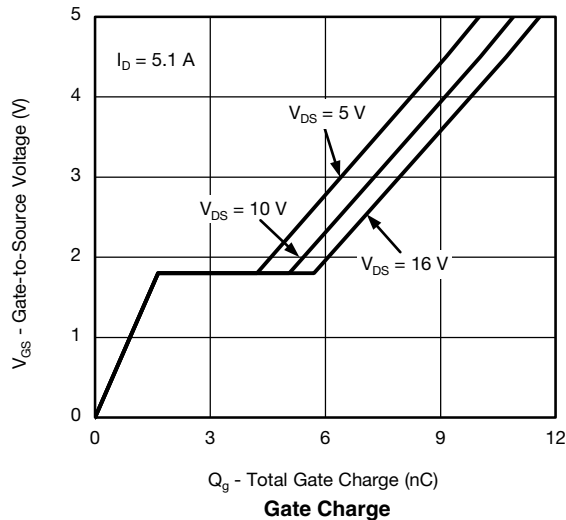

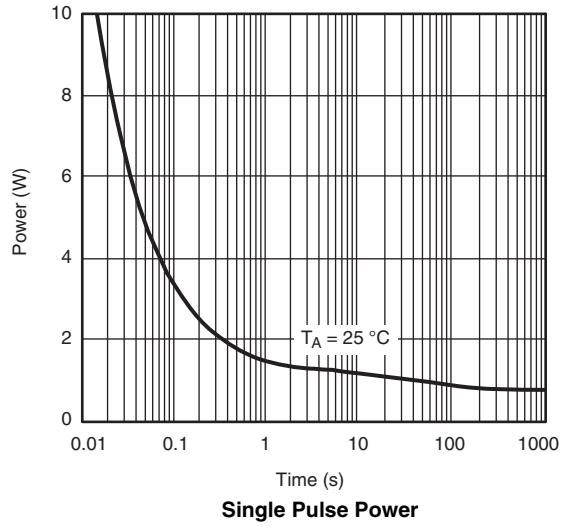
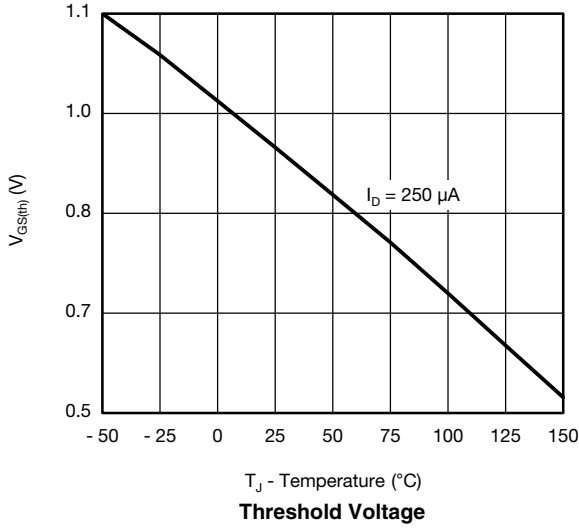


Gate Charge
