



### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted












#### Source-Drain Diode Forward Voltage








### **Threshold Voltage Variance Over Temperature**

Single Pulse Power, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Ambient






