






- Normalized Transient Thermal Impedance Junction-to-Ambient (25 °C)

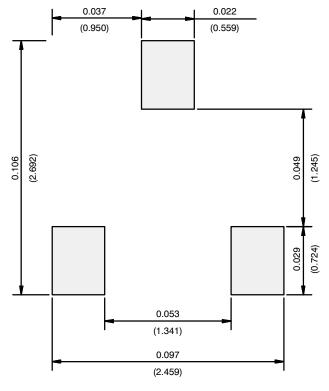
