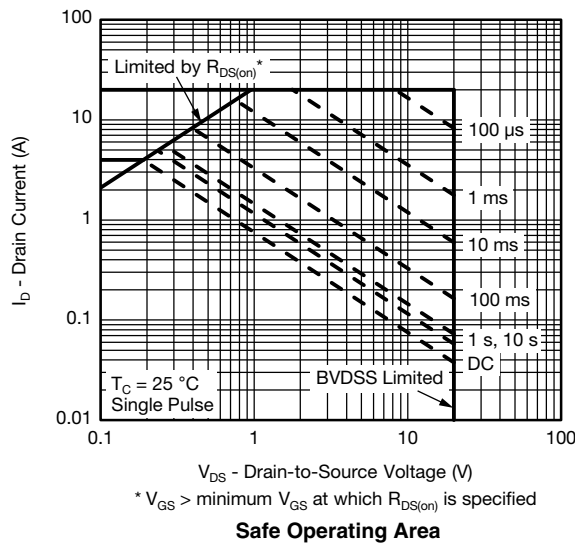
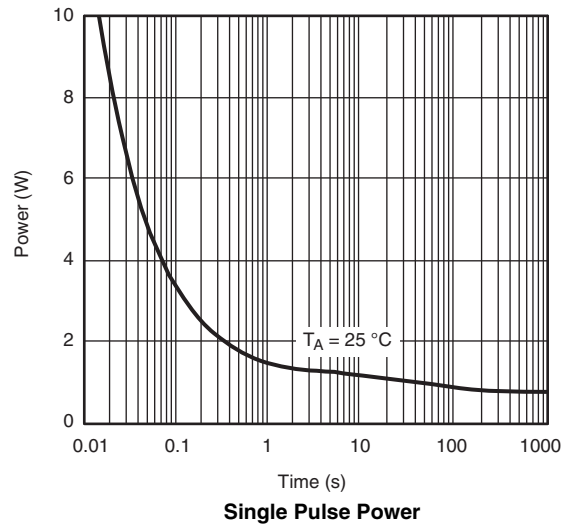
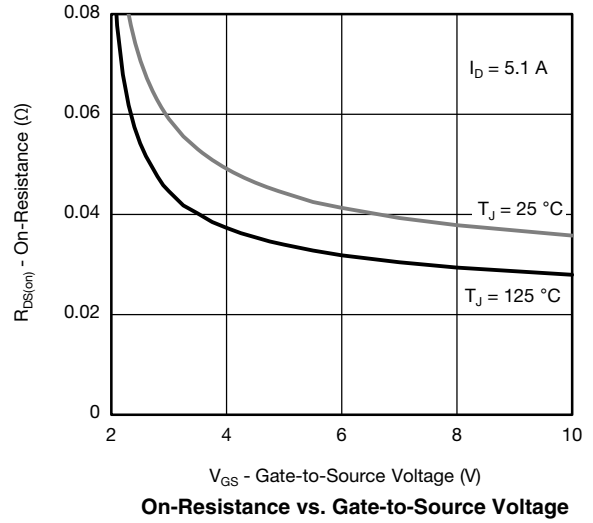
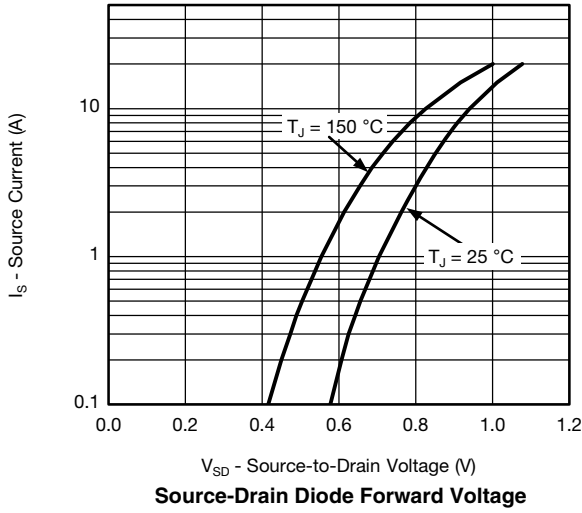
On-Resistance vs. Drain Current and Gate Voltage

Capacitance

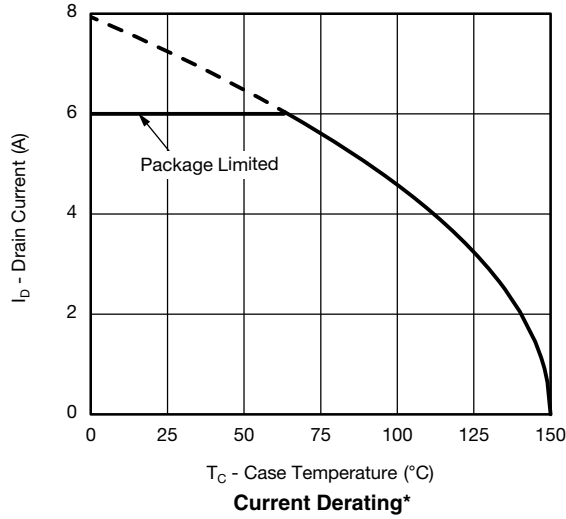


On-Resistance vs. Junction Temperature

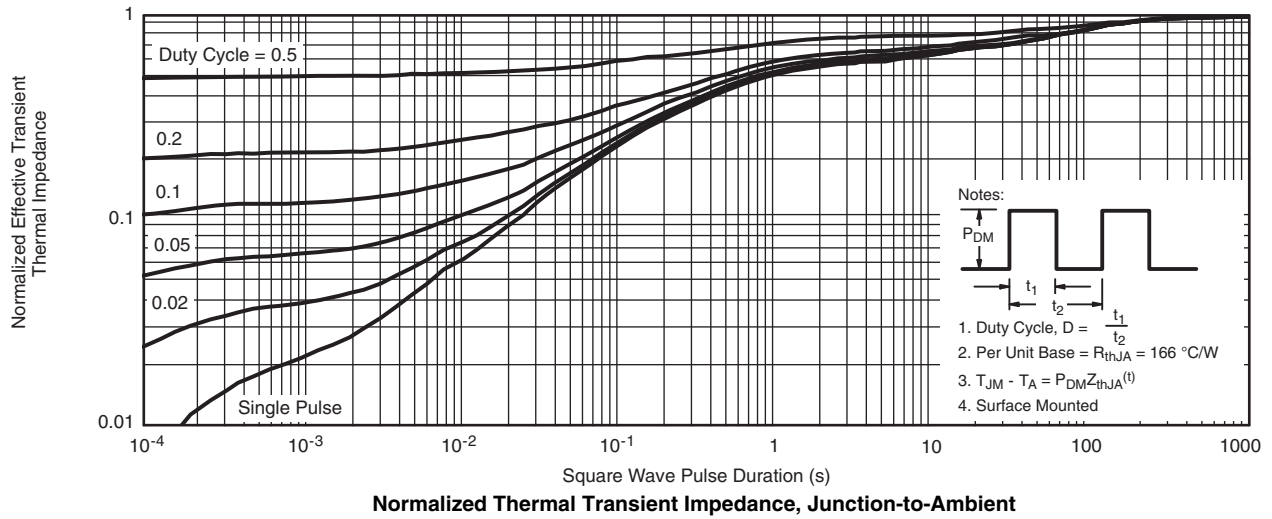

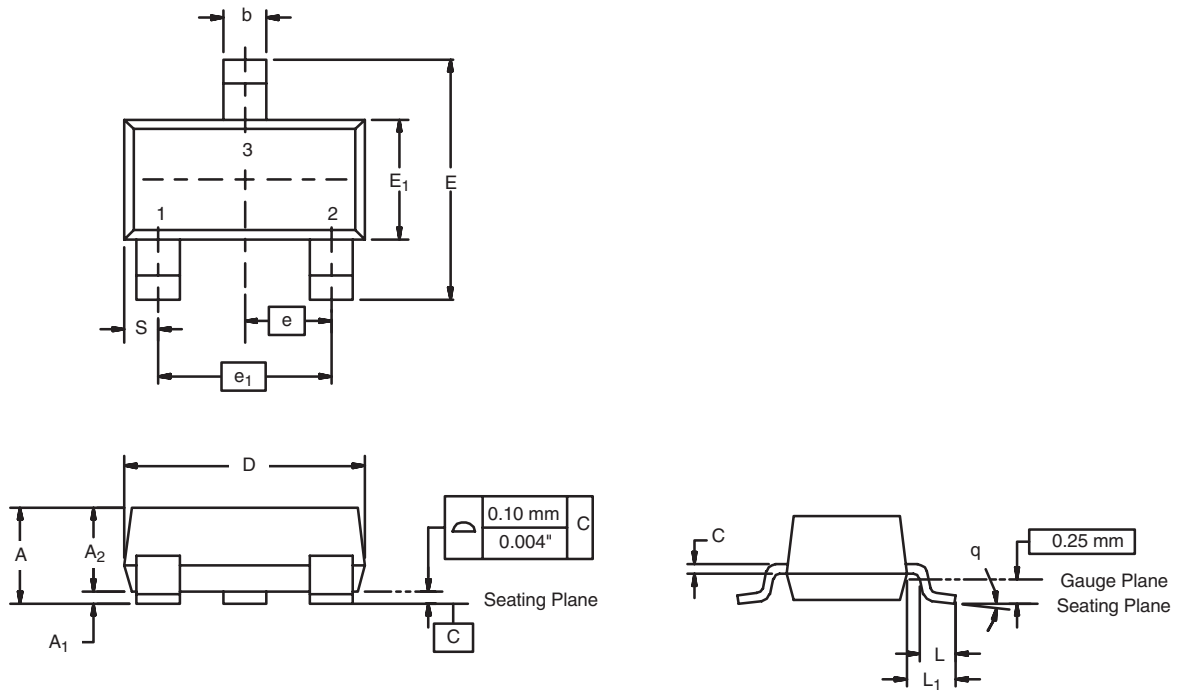
