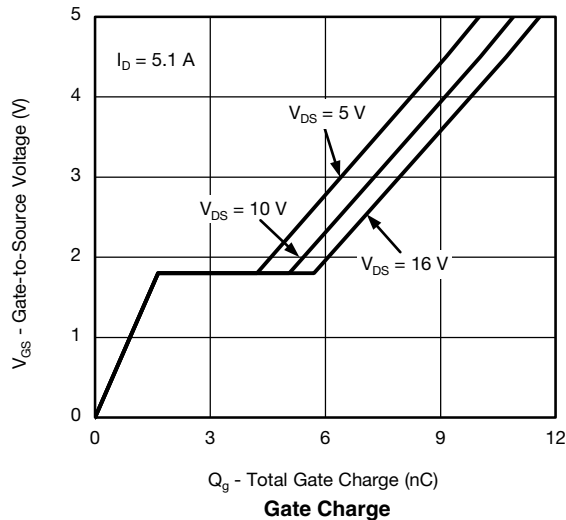

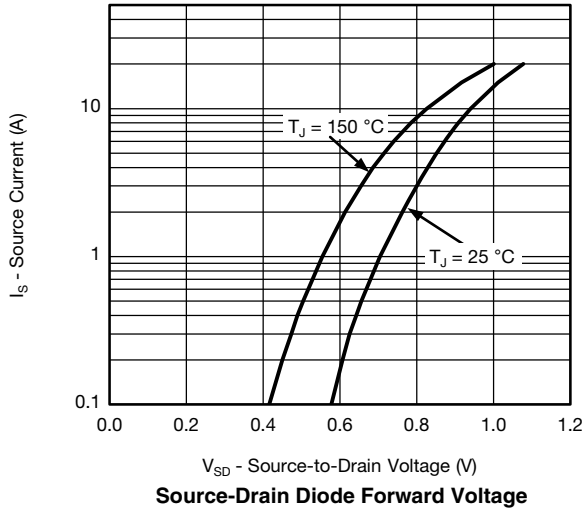


**Gate Charge**
