













Source-Drain Diode Forward Voltage








Threshold Voltage Variance Over Temperature


Single Pulse Power, Junction-to-Ambient

THERMAL RATINGS (T_A = 25 °C, unless otherwise noted)




Normalized Thermal Transient Impedance, Junction-to-Foot




