



V<sub>SD</sub> - Source-to-Drain Voltage (V)




On-Resistance vs. Gate-to-Source Voltage









### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Normalized Thermal Transient Impedance, Junction-to-Foot


