TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






T_J - Junction Temperature (°C) On-Resistance vs. Junction Temperature

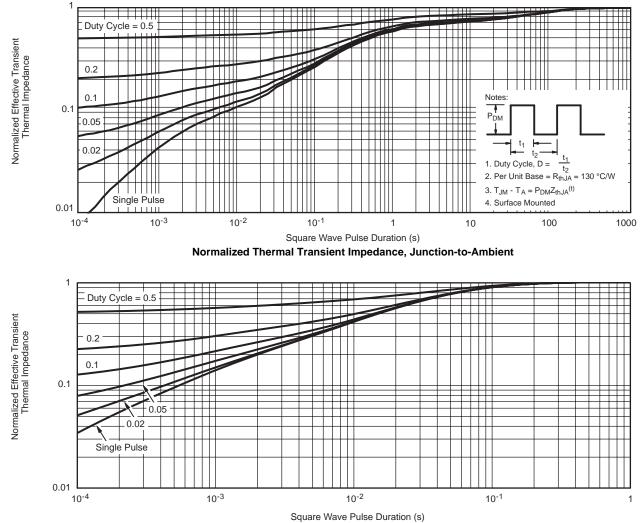




Normalized Thermal Transient Impedance, Junction-to-Foot
