




V<sub>DS</sub> - Drain-to-Source Voltage (V) Capacitance






**On-Resistance vs. Junction Temperature** 




On-Resistance vs. Gate-to-Source Voltage




Source Drain Diode Forward Voltage



Threshold Voltage




Drain Source Breakdown vs. Junction Temperature






