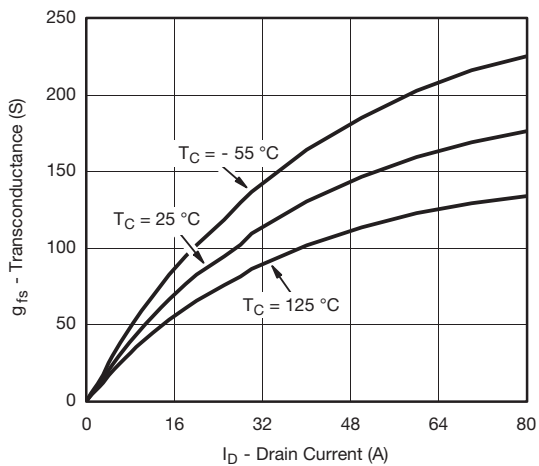

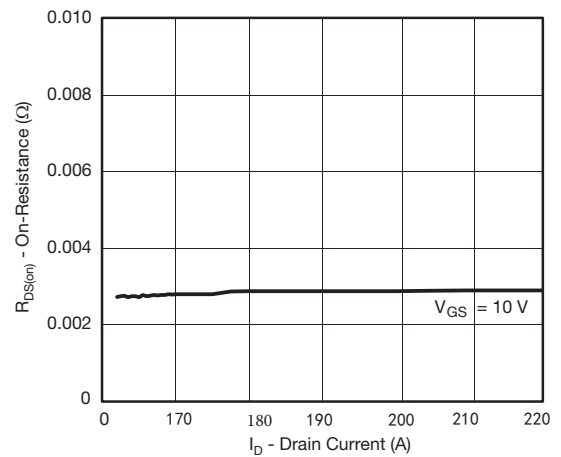

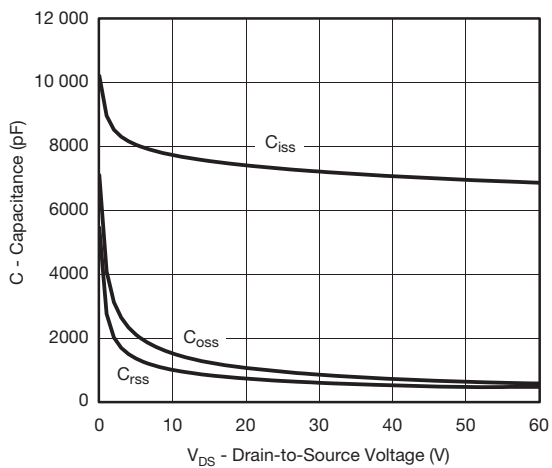

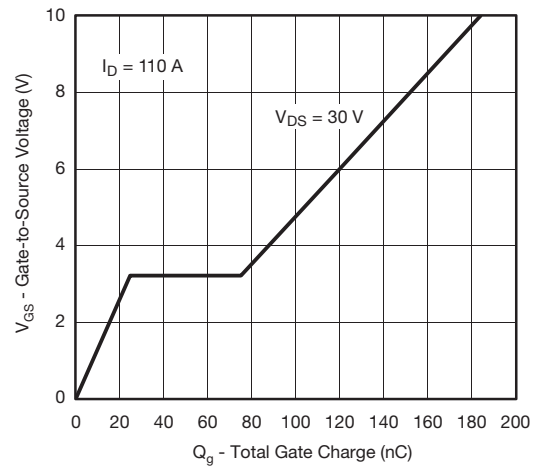
Transconductance

Gate Charge

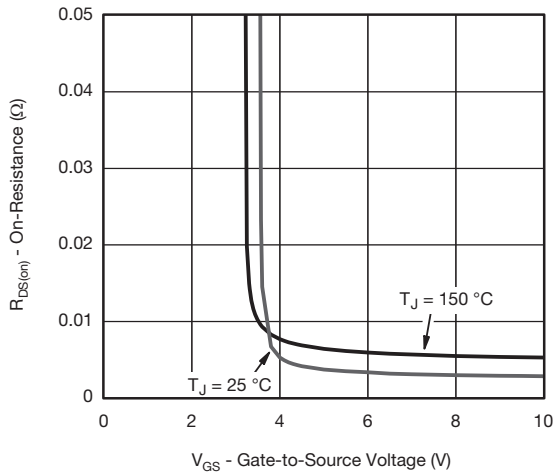

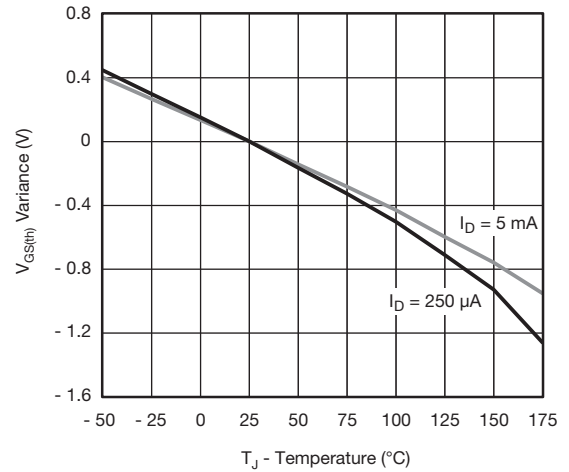
On-Resistance vs. Junction Temperature



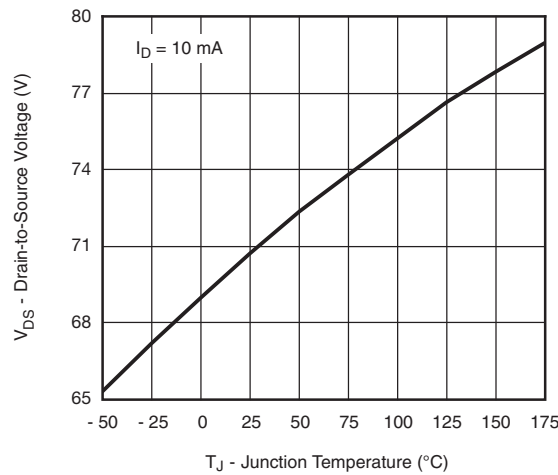
Source Drain Diode Forward Voltage

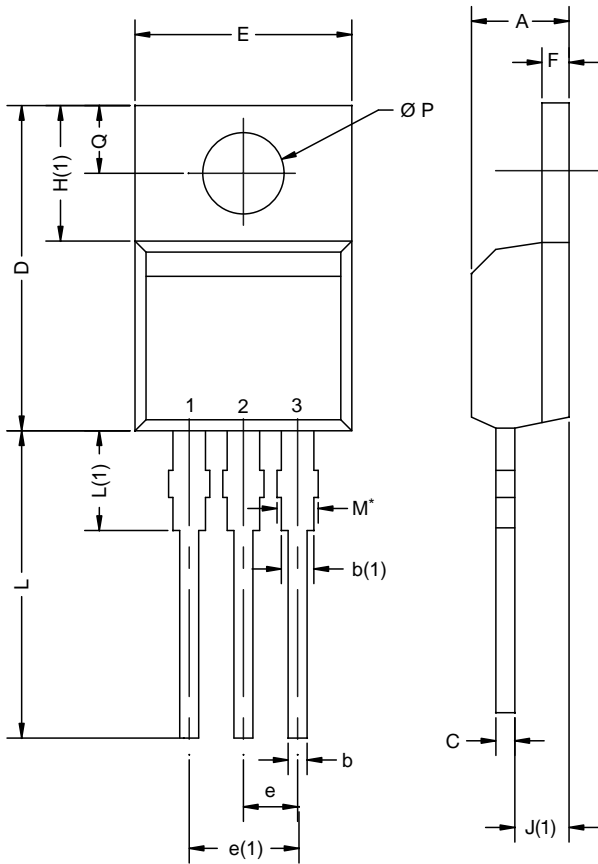


Normalized Thermal Transient Impedance, Junction-to-Case
