




On-Resistance vs. Drain Current

Avalanche Current vs. Time





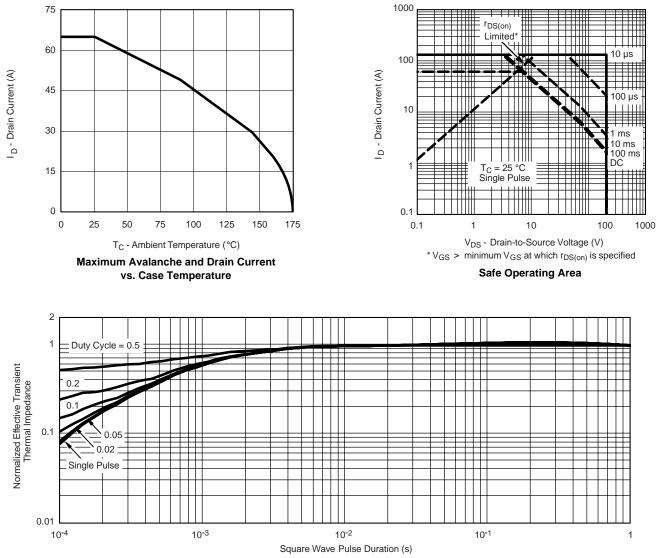


Source-Drain Diode Forward Voltage






