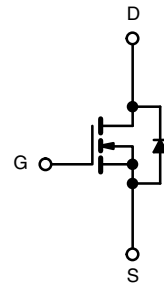
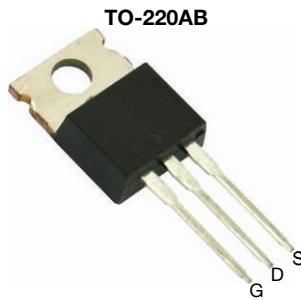

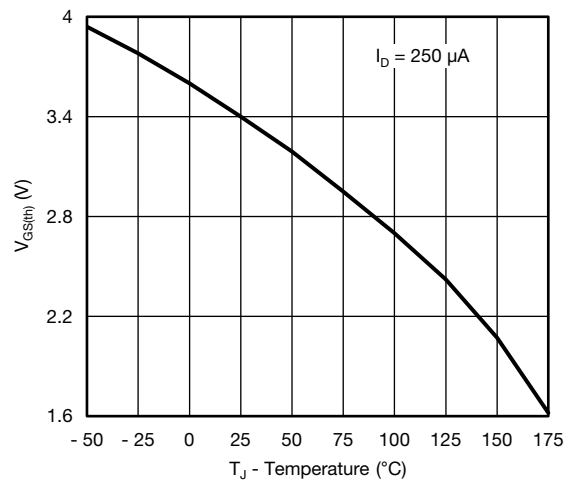
**On-Resistance vs. Junction Temperature**

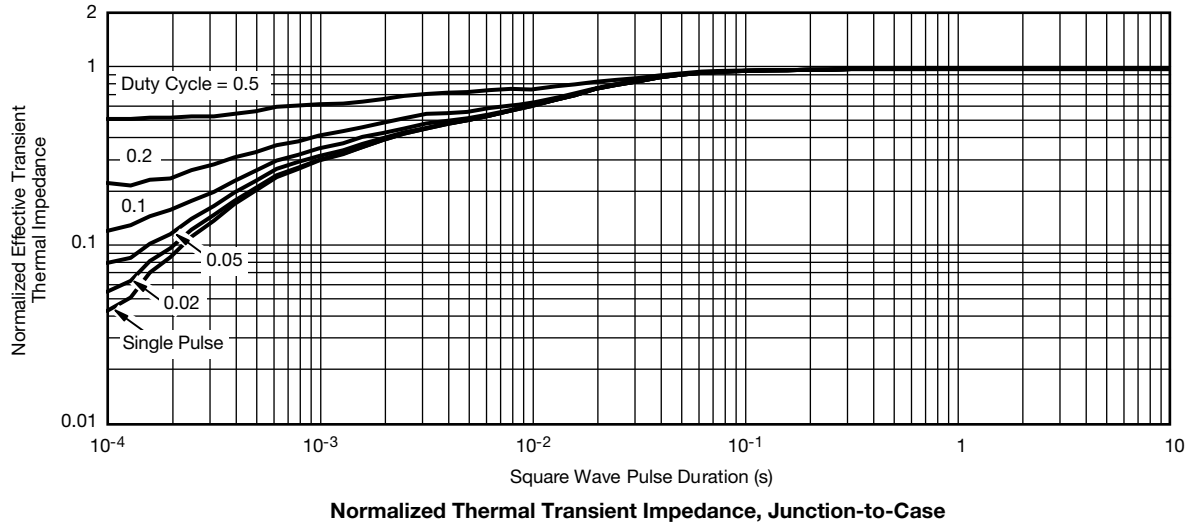


**Drain Source Breakdown vs. Junction Temperature**
