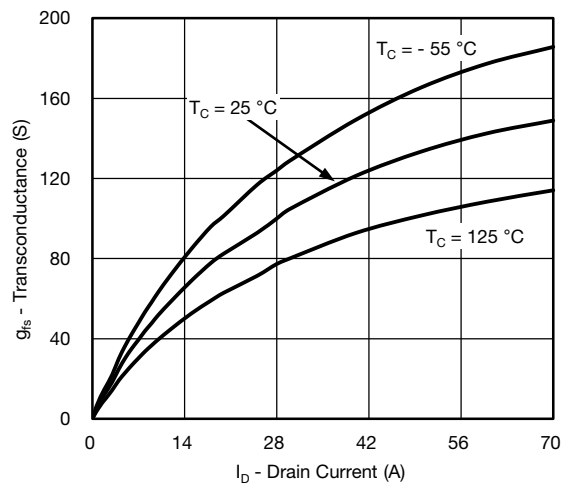

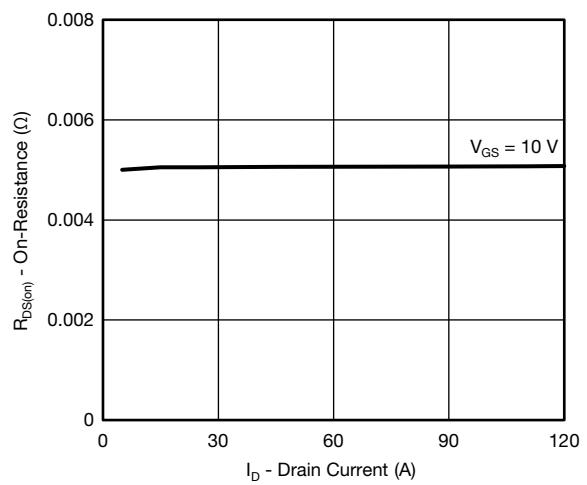

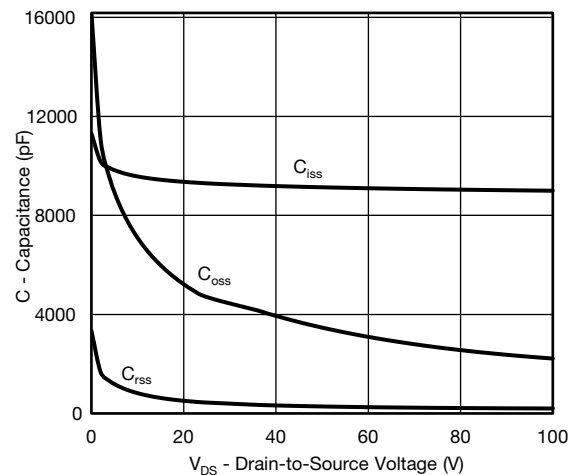

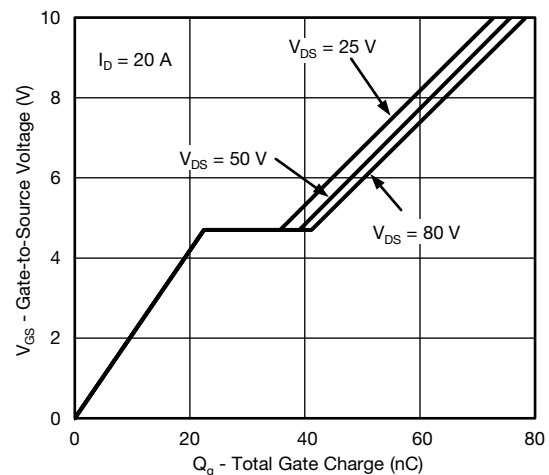

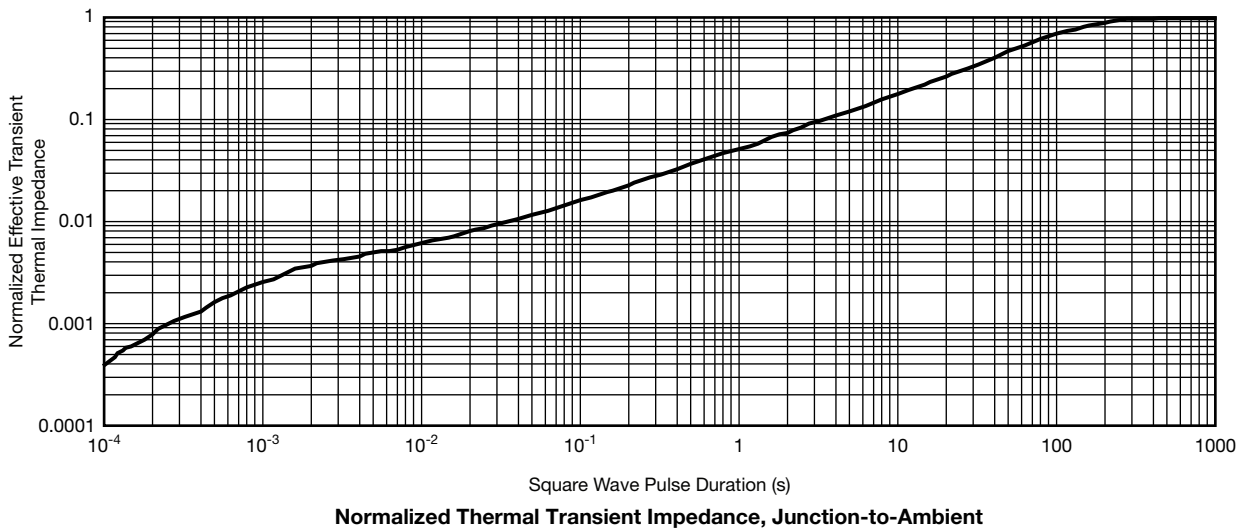
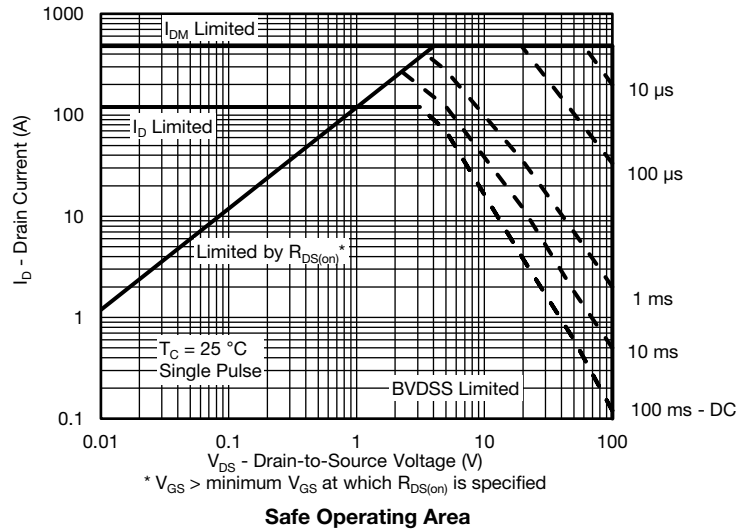

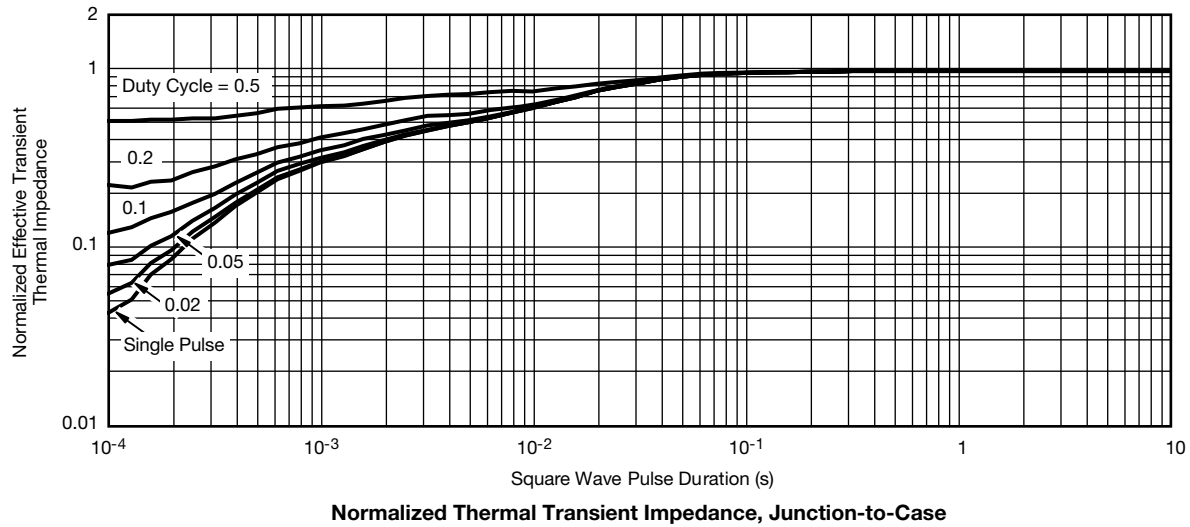


**Drain Source Breakdown vs. Junction Temperature**

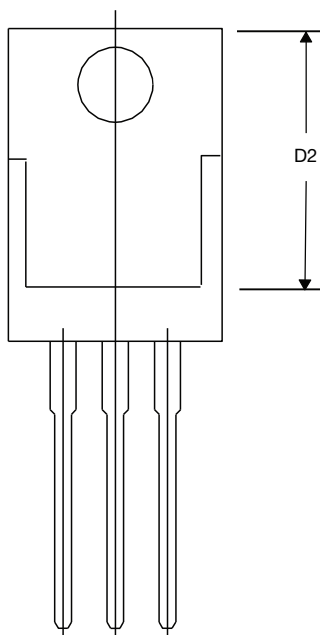
