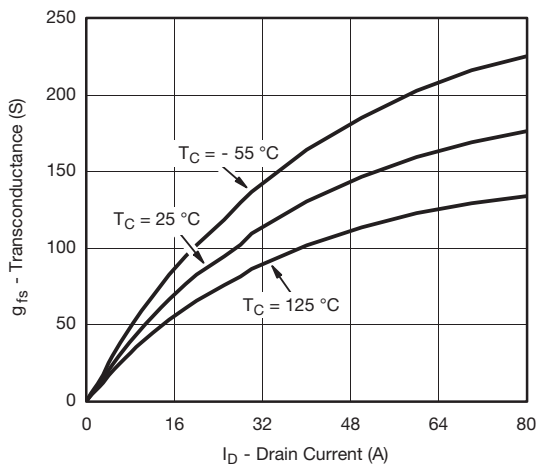

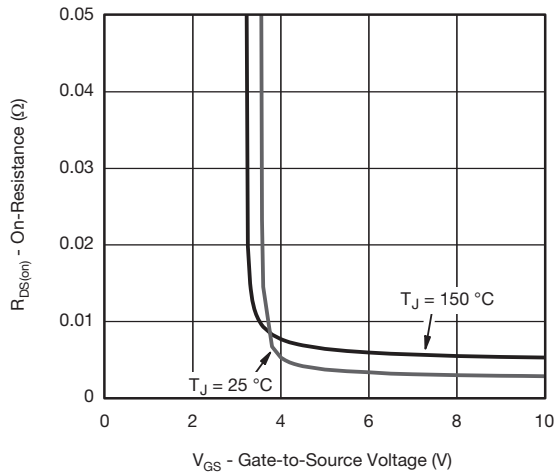

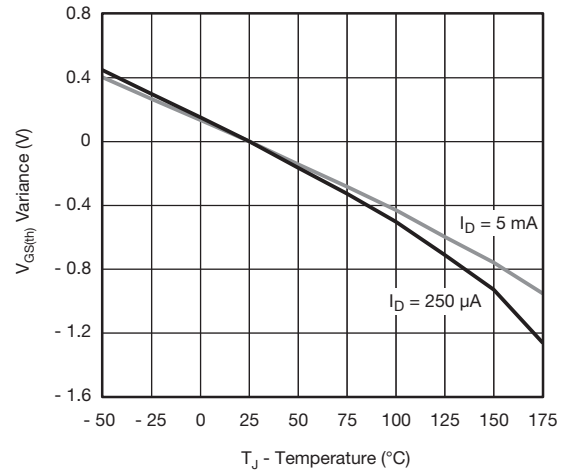
**On-Resistance vs. Junction Temperature**

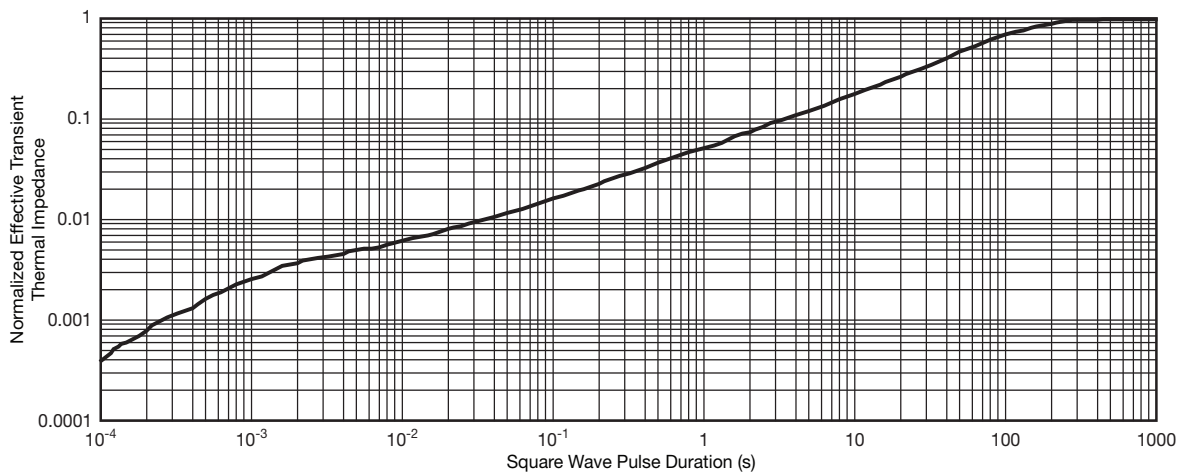


**Drain Source Breakdown vs. Junction Temperature**

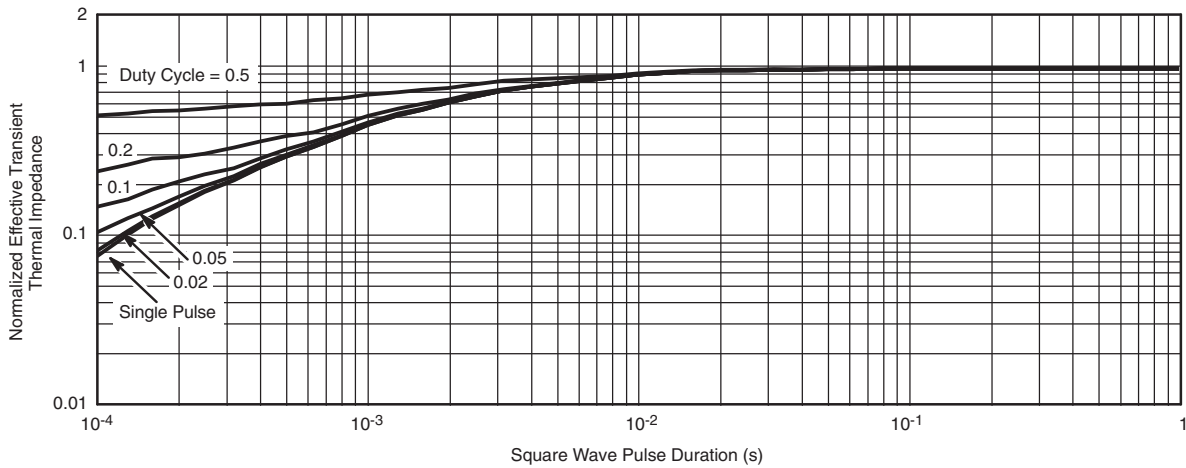


**Safe Operating Area**

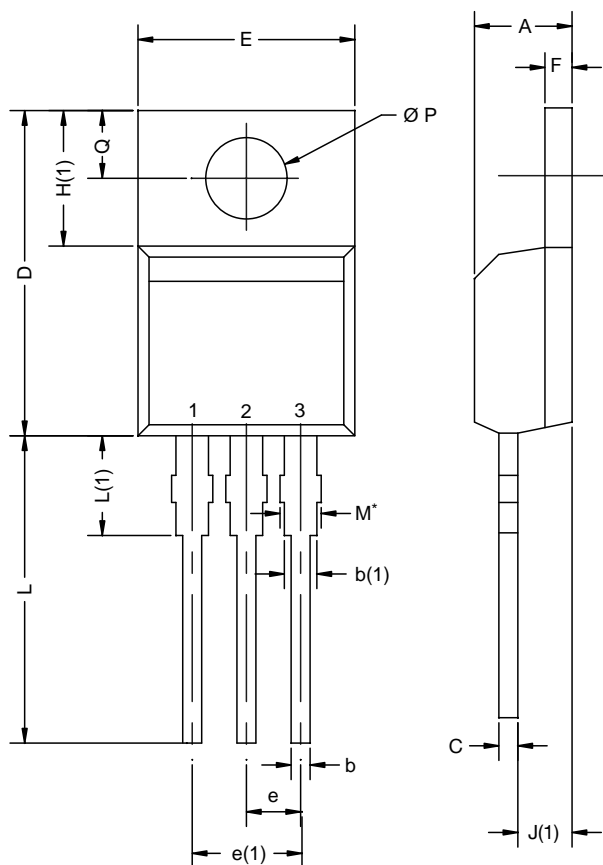


**Normalized Thermal Transient Impedance, Junction-to-Case**
