




TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted









On-Resistance vs. Junction Temperature






Source-Drain Diode Forward Voltage



Drain Source Breakdown vs. Junction Temperature



Maximum Avalanche and Drain Current vs. Case Temperature




Square Wave Pulse Duration (s)
