



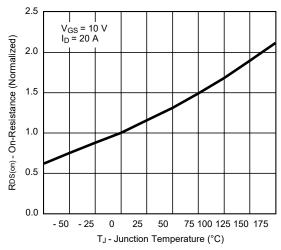




On-Resistance vs. Junction Temperature




Source-Drain Diode Forward Voltage




**Maximum Drain Current vs. Ambient Temperature**
