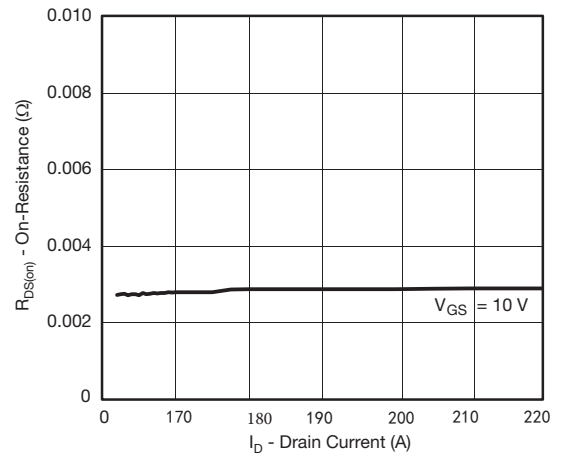

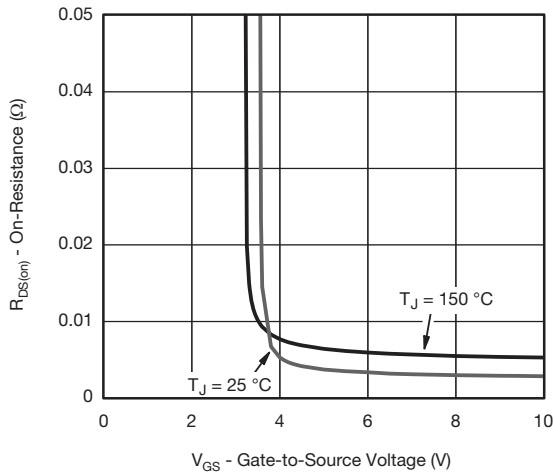

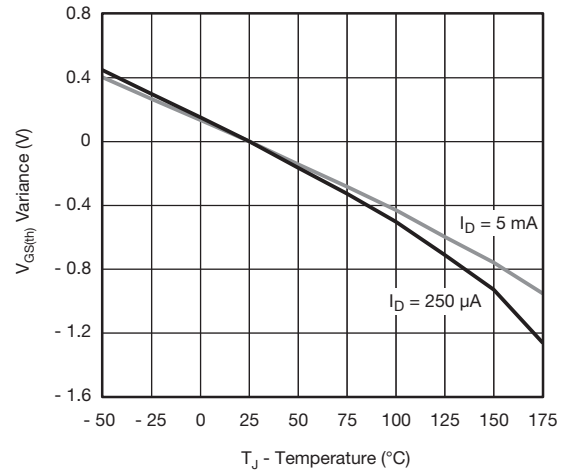
**On-Resistance vs. Junction Temperature**



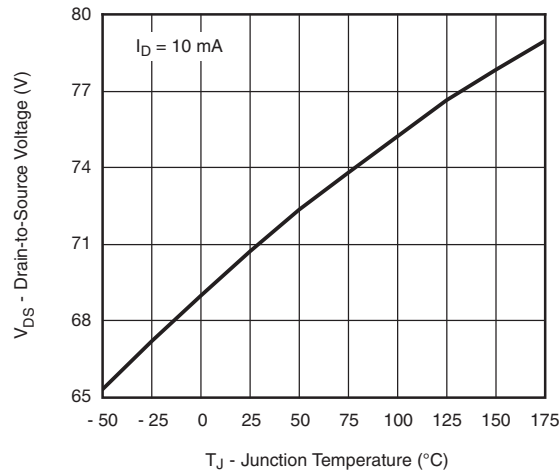
**Source Drain Diode Forward Voltage**

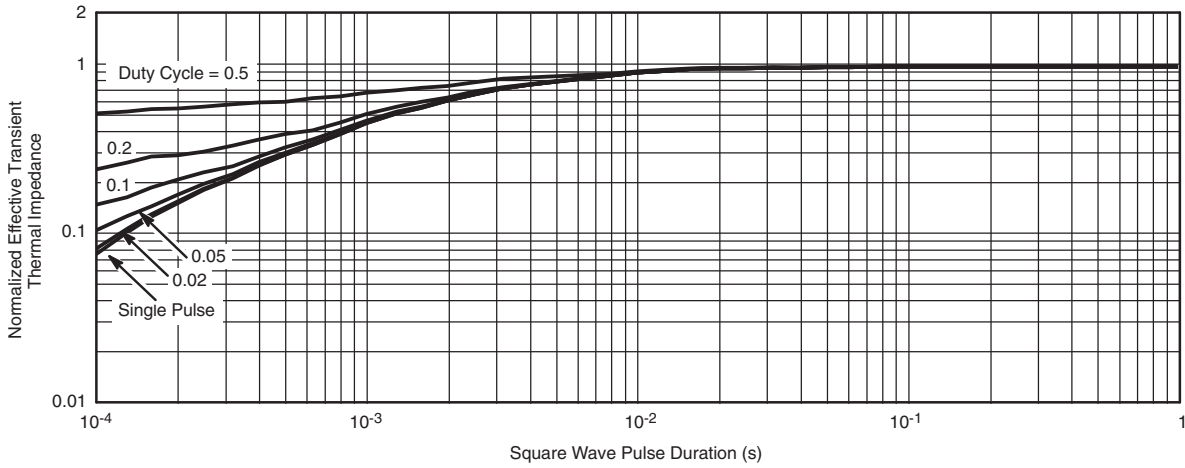


**Safe Operating Area**

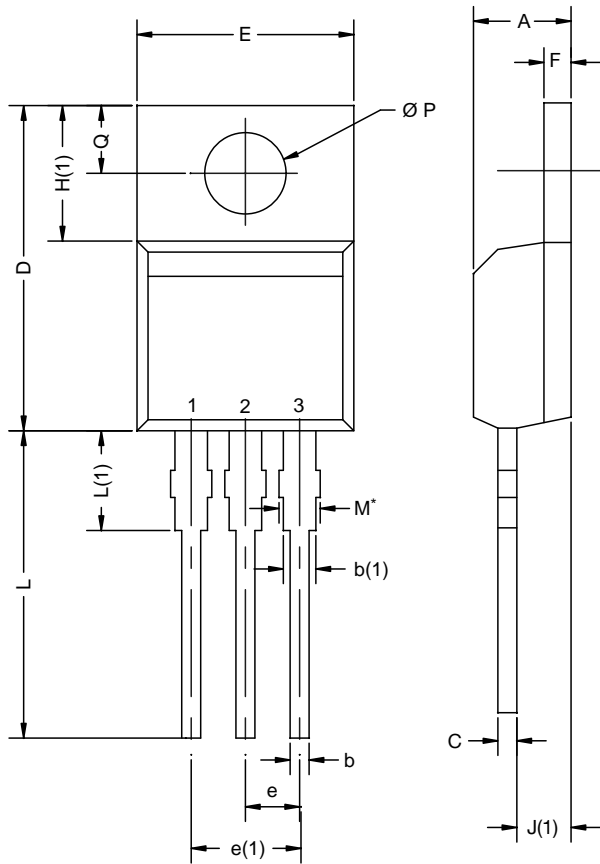
