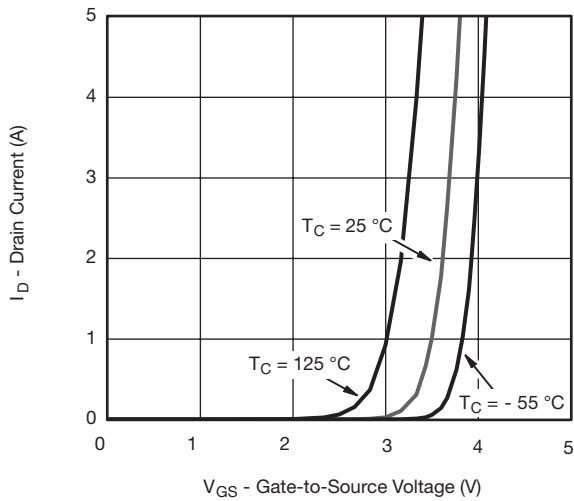

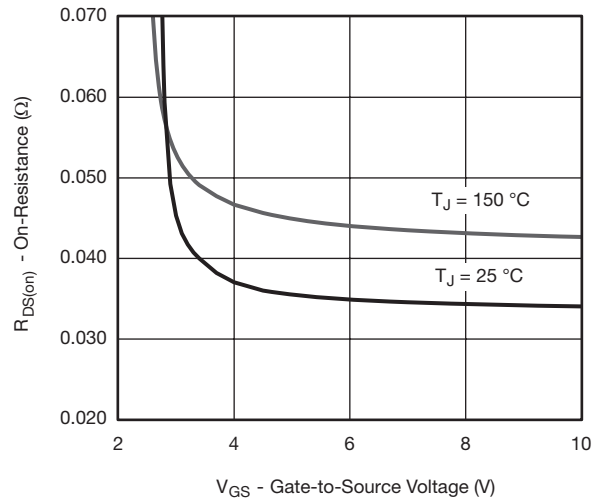
**Drain to Source Voltage vs.  $I_D$**



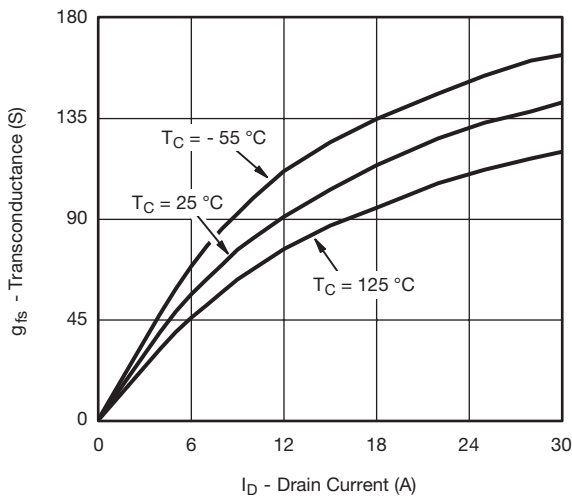
**On-Resistance vs. Drain Current**



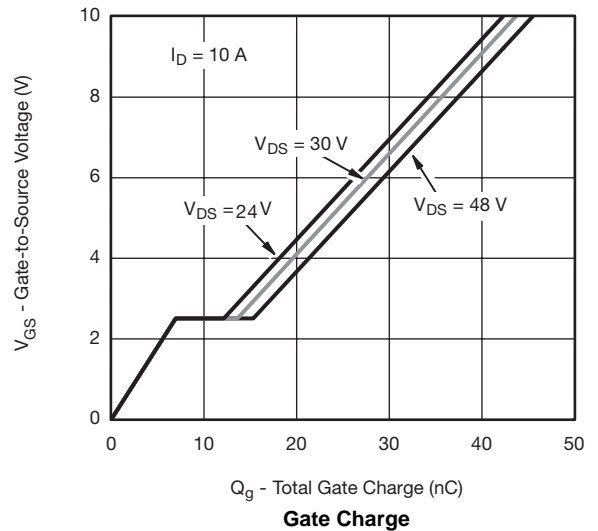

**On-Resistance vs. Gate-to-Source Voltage**

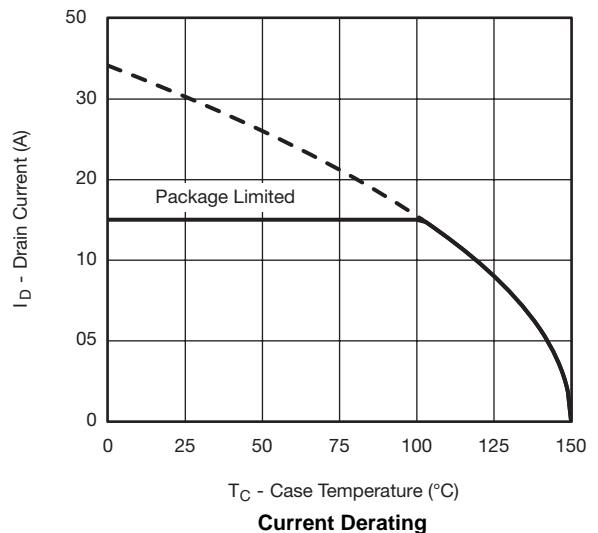
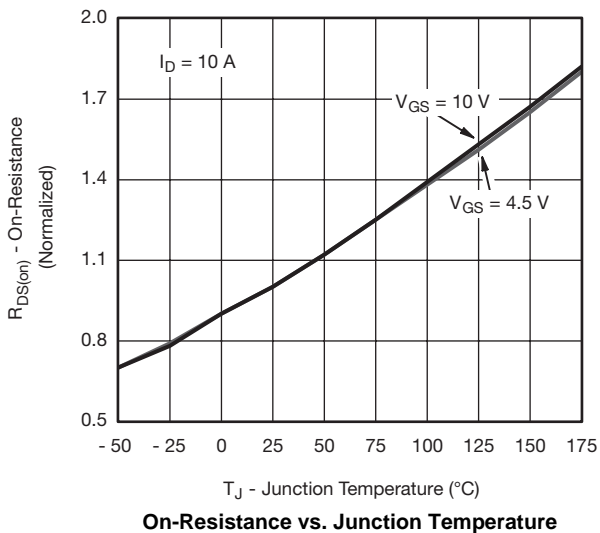
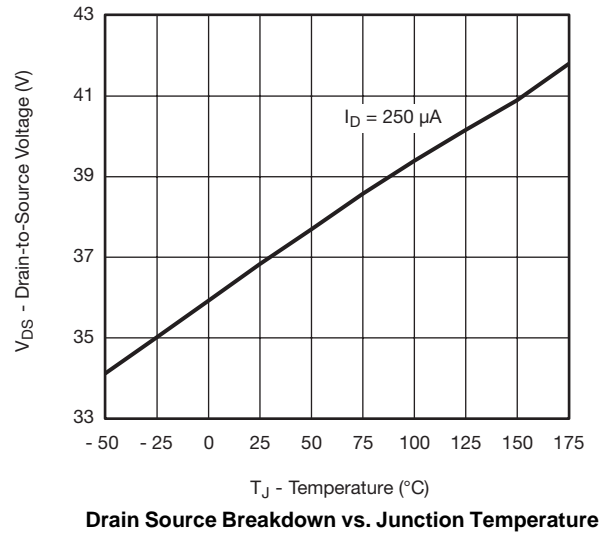
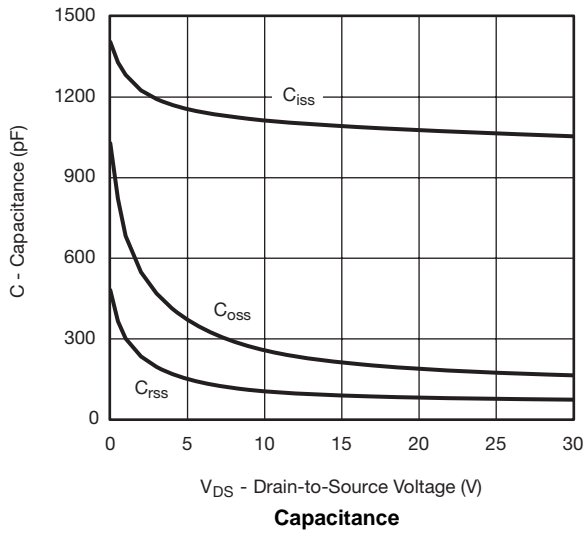
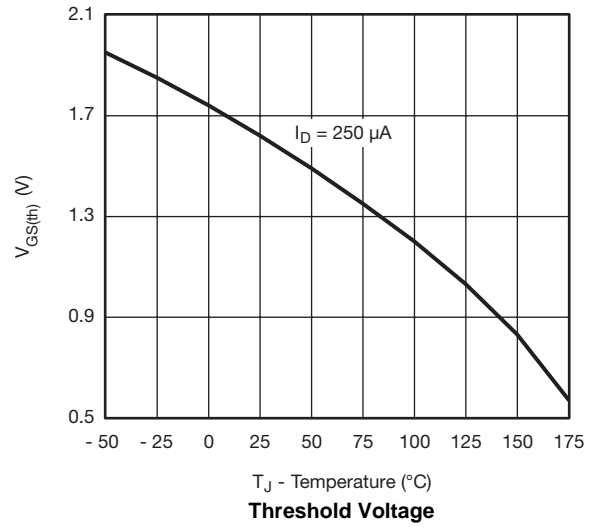
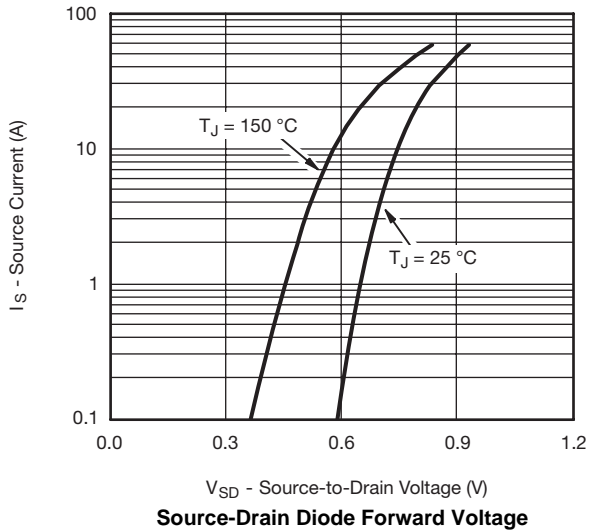

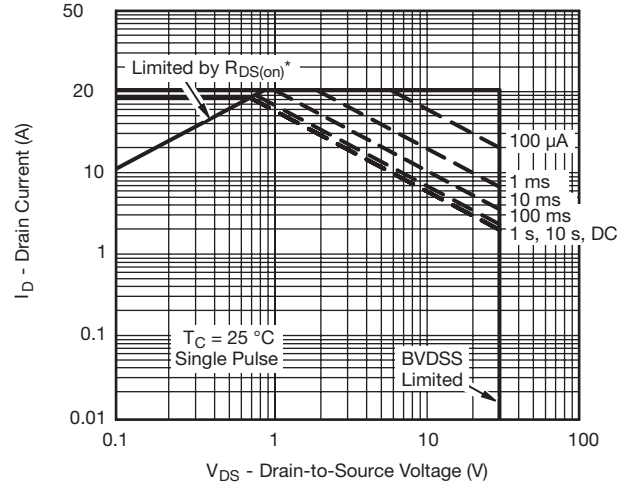

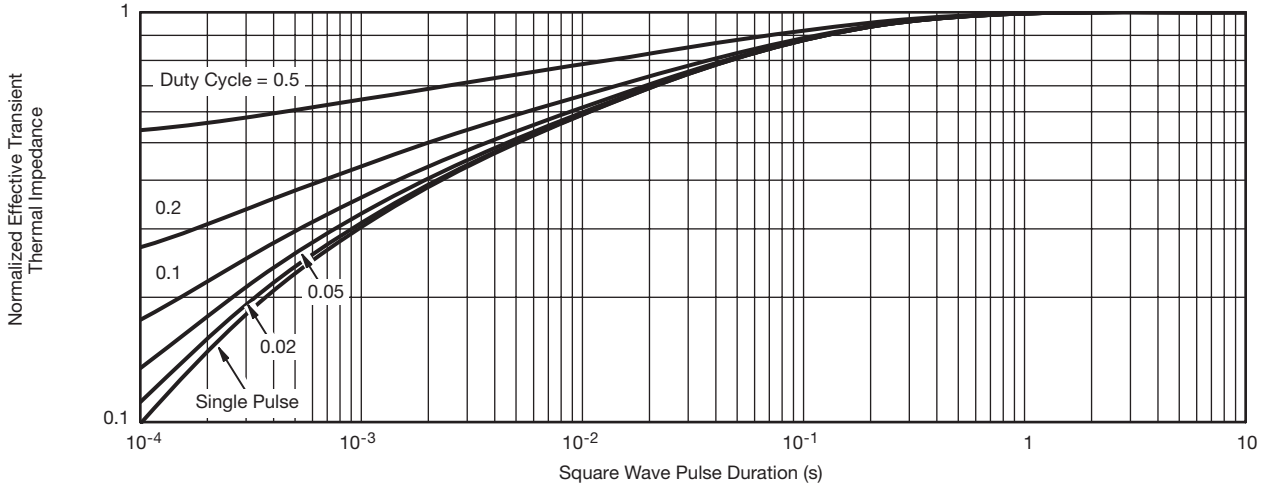

**Single Pulse Avalanche Current Capability vs. Time**

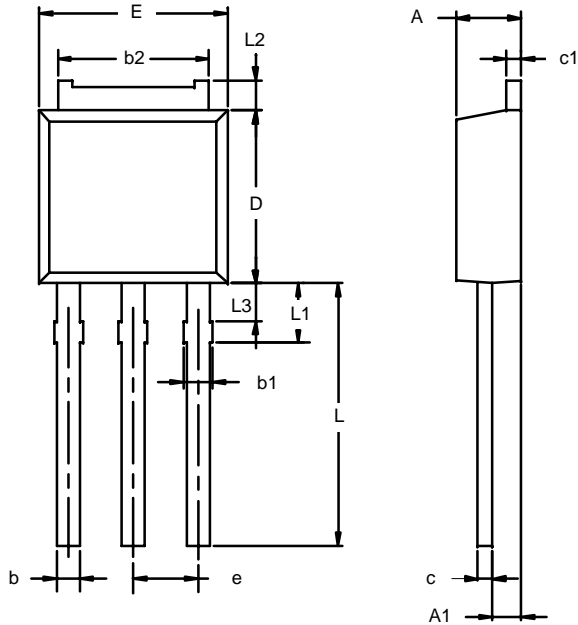
