

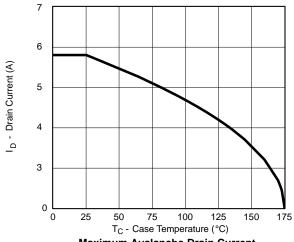


On-Resistance vs. Junction Temperature



Maximum Avalanche Drain Current vs. Case Temperature






Square Wave Pulse Duration (s)


