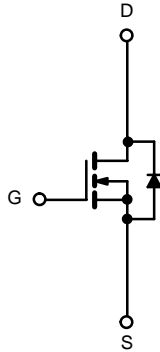

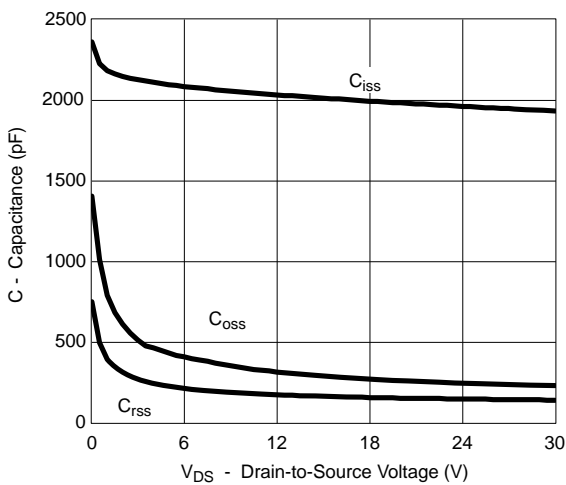

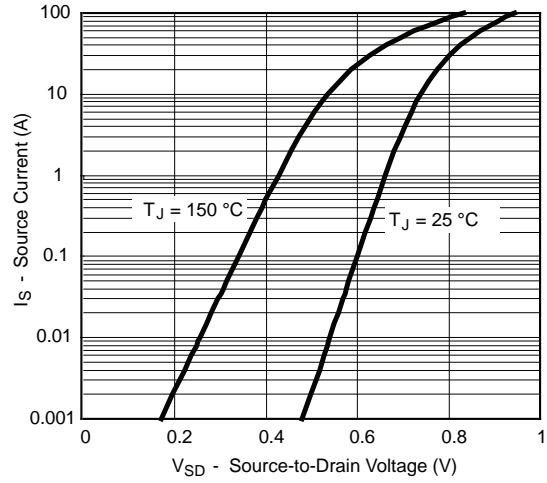

On-Resistance vs. Junction Temperature



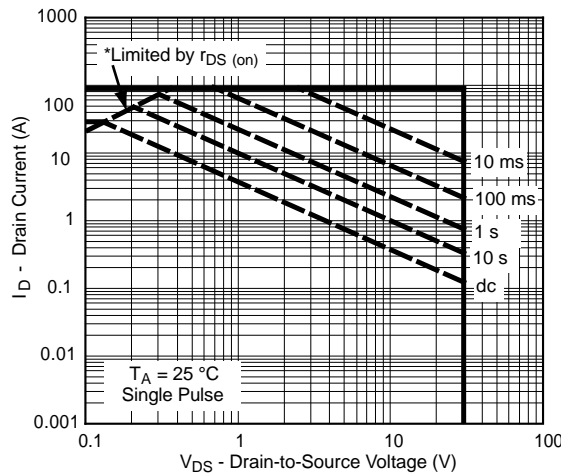
Forward Diode Voltage vs. Temperature



$R_{DS(on)}$ vs. V_{GS} vs. Temperature

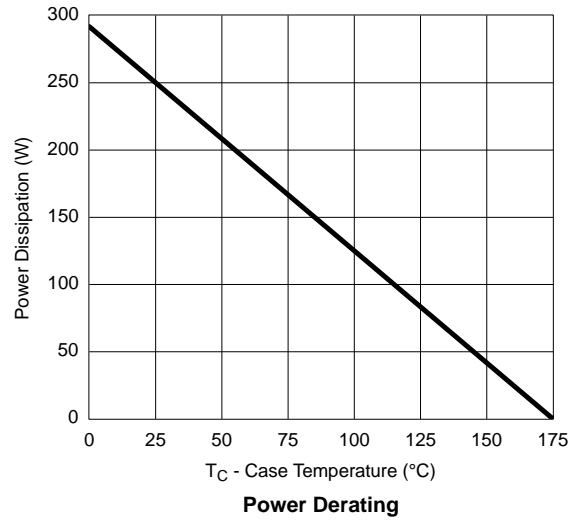


Threshold Voltage

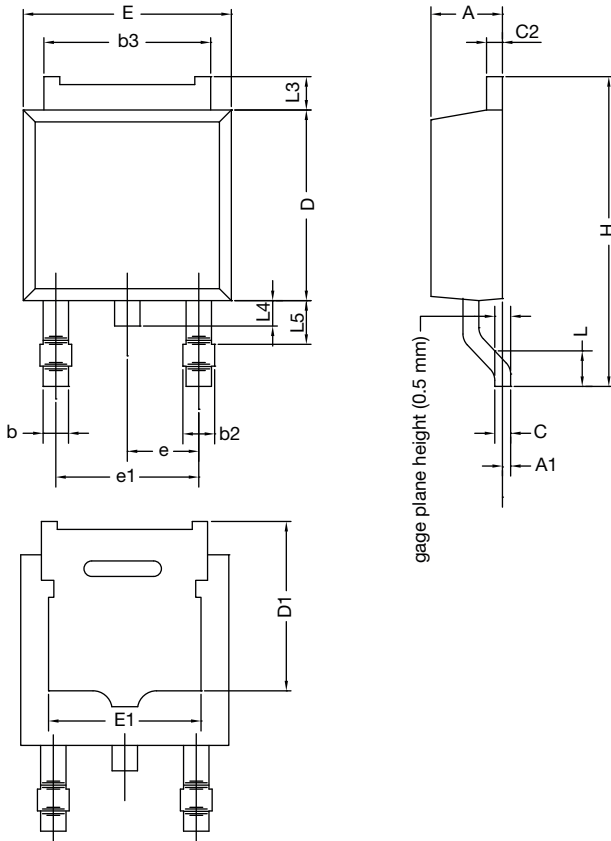
TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)

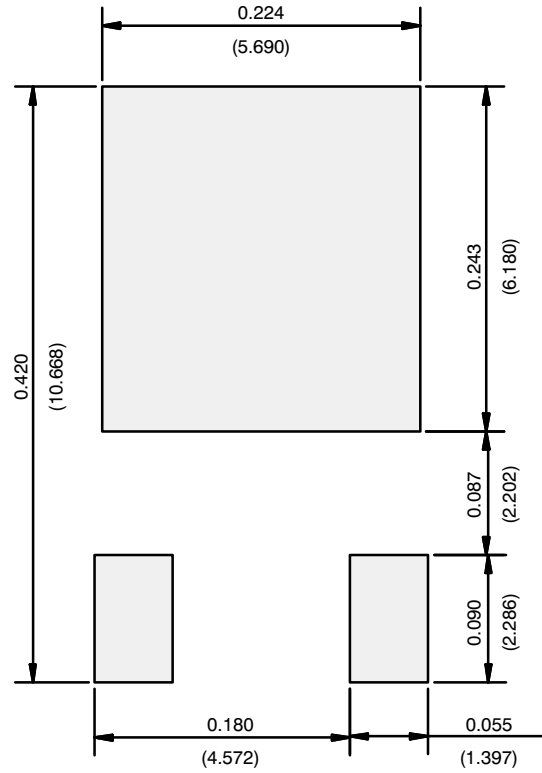
