








On-Resistance vs. Drain Current



Gate Charge






On-Resistance vs. Junction Temperature




Drain Current vs. Case Temperature



Source-Drain Diode Forward Voltage




Safe Operating Area




Normalized Thermal Transient Impedance, Junction-to-Case
