




#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted



#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






T<sub>J</sub> - Junction Temperature (°C) Drain Source Breakdown vs. Junction Temperature




